**Me Care Terms & Agreements: New Account Form** must be signed with opening order.

**Opening Orders:** Opening orders must be a minimum of \$300. There is no minimum for reorder.

**Testers:** When ordering 6 or more of one SKU, 1 tester will be received free. When purchasing 3 or more, 1 tester will be 50% off wholesale price. Testers are from the core line only – Bluegrass Body Scrub, 3-in-1 Whisked Sugar Scrub Wash, Midnight Moon Moisturizer, and Bootleg Body Butter.

**Shipping Costs:** Shipping cost is not included in the subtotal and will be added to each order. Shipping costs generally run 10% of your total purchase price. A \$10 **Handling Fee** will be applied to orders under \$50.

**Shipping Time and Payment:** All purchase orders received will be confirmed within 48 hours and typically shipped within 2 days (exceptions may apply for specific labeling, packaging, holidays and large quantity orders). After opening order, and with approved credit, payment is due within 30 days. **ALL opening orders** must have a credit card on file. All Net 30 orders must also have a credit card on file, unless otherwise approved.

**Late Fees:** All past due accounts not paid within 30 days, will be charged at a fee of 5% of outstanding balance on a monthly basis until paid. Returns and Exchanges: Call for approval of returns/exchanges. Products must be returned in original, non-ticketed packaging and in an unused, resalable condition. **For undeliverable and refused shipments**, a 25% restocking fee will be applied to the customer's account.

**Co-Branding:** This is offered when ordering 100 or more co-labeled units per sku. There is an additional cost for price of labels that is calculated based on size of order. A \$300 label design option is offered if you would like our design team to custom make the label for you.
